Mr. Vietor and Mr. Dunn discussed dates for the assessment. The decision was made to schedule the assessment for Thursday, June 12, 2025, at 9:00 a.m. Mrs. Delph volunteered to proctor the exam.

Ms. Powell asked for clarification as to whether the candidate for Street Maintenance Worker will participate in assessment testing and an interview.

The commission confirmed that once the scores are certified, as long as the candidate passes the exam, there is no need for the candidate to participate in the assessment or interview process.

After commission discussion, the commission agreed to meet on June 18, 2025, at 9:00 a.m. to certify the assessment and interview scores.

Mr. Dunn asked if the new hire classified advertisement could be approved at the June 18, 2025, meeting?

Mrs. Woeste confirmed the ad may be certified as long as everything is confirmed.

Mr. Kempe said he proctored the Street Division exams yesterday and everything went smoothly.
