Merit System Commission Minutes - August 6, 2025

Mr. Kempe asked if there were any changes or corrections to the August 6, 2025, Merit System Commission meeting minutes. Hearing none, the minutes were approved as submitted.

Business

Police Division Hiring

Chief Richardson requested that the current hiring lists be terminated. He reported one lateral position and one entry-level position were filled from the respective lists. He said there are no more viable candidates available. He asked for approval of a new entry level (no OPOTA) process and a new lateral entry process to run simultaneously. He noted there is one open spot the Police Division is trying to fill, and there will be three open positions after the first of the year. He stated there will be four retirements next year, one as early as January. He reported that Council did increase his budget, and there are extra spots on the Table of Organization that will be funded for six months so he can hire ahead of some of the retirements.

Mrs. Delph moved to terminate the lists for Entry Level (No OPOTA) and Lateral Entry positions; Mr. Watts seconded the motion.
